## 02 APPLY

- Apply for your selected course before the nomination deadline (i.e., 2359hr SGT of stated date).
- Follow instructions to fill in your application.
- Upload corresponding documents when prompted.
- Save a draft application, where required. Please note that draft applications will be deleted after 3 working days.

## 03 REVIEW AND SUBMIT


- Please ensure that all information provided is accurate before submission.
- All applications must be submitted online before the nomination deadline.
- If your application is successful, an acknowledgement email with a link to your application will be sent to you.
- Your supervisor and National Focal Point for Technical Assistance will need to endorse the application via an email link.


## 04 CONFIRMATION OF ACCEPTANCE


- Successful applicants will receive an invitation via email to participate in the course.
- Please accept the invitation as early as possible to confirm your placement.
- You will be notified via email if your placement is successful.

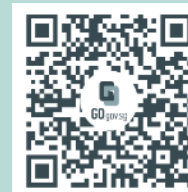
# SUSTAINABILITY
